Sub: Scrutinizer's Report on voting through remote E-voting for Postal Ballot.

I, Aditi Patnaik, Partner, M/s. Mehta & Mehta, Practicing Company Secretaries (Membership No. 45308 & Certificate of Practice No. 18186), have been appointed as a Scrutinizer by the Board of Directors of Nexus Select Mall Management Private Limited (hereinafter referred to as "NSMMPL") Manager to "Nexus Select Trust" (hereinafter referred to as the "REIT") vide Resolution passed at their meeting held on February 06, 2024 to scrutinize the postal ballot through remote e-voting in a fair and transparent manner and ascertain the requisite majority on the said postal ballot carried out pursuant to the provisions of Securities and Exchange Board of India (Real Estate Investment Trusts) Regulations, 2014 and any other applicable law, rules and regulations. I hereby submit my Report, as under:

- 1. The Notice of Postal Ballot ("Notice") was sent to the Unitholders of the Nexus Select Trust REIT vide e-mail on Wednesday, February 14, 2024.
- 2. The remote e-voting period commenced on Thursday, February 15, 2024 (09:00 a.m. 1ST) and ended on Friday, March 15, 2024 (05:00 p.m. 1ST)
- 3. The remote e-voting facility was provided by National Securities Depository Limited ("NSDL").
- 4. The Notice of Postal Ballot was sent in electronic form only to all the unitholders whose names appear in the Register of Members / List of Beneficial Owners as received from National Securities Depository Limited ("NSDL") and Central Depository Services (India)



Limited ('CDSL') and whose e-mail addresses are registered with the Company/ KFin Technologies Limited (RTA)/Depository.

- 5. As the manner of voting on the proposed resolution was restricted only to voting through remote e-voting, the hard copies of the Notice along with Postal Ballot forms and pre-paid business envelope were not sent to the Unitholders for the Postal Ballot. Accordingly, the communication of the assent or dissent of the unitholders took place through the remote evoting system only.
- 6. The unitholders of the Company holding units as on the "cut off" date i.e., Thursday, February 08, 2024, were entitled to vote on the proposed resolution.
- 7. The register has been maintained electronically to record the assent or dissent received, mentioning the particulars of name, address, folio number or client ID of the unitholders, and number of units held by them.
- 8. The result of the scrutiny of the above postal ballot through remote e-voting in respect of passing of resolution contained in the Notice dated Tuesday, February 06, 2024 is as under:
